# Amino Acids Analysis of the Four Mushroom Species, Antioxidant Activity and Immunostimulant Evaluations of their Polysaccharides Extracts

# ABSTRACT

Mushrooms have been valued as edible and medical resources. This project aimed to evaluate of four mushrooms such as *Pleurotus ostreatus* (Fr.) Kummer, *Pleurotus opuntiae* (Dur.& Lev.) Sacc., *Pleurotus sajor-caju* (Fr.) Sing, and *Ganoderma lucidum* (Curtis) for amino acids, two extraction methods, antioxidant activity, total phenolic content, <sup>1</sup>H NMR analysis and *in vitro* immunostimulant activity, compared the cultivation between TISTR and Nakhon Prathom area. The results showed that glutamic acid and aspartic acid were abundant amino acids, while alanine, leucine, lysine, arginine, serine, phenyl alanine and threonine were found varied in those mushrooms. The most

common amino acids found in *P. sajor-caju* were found in lower amounts in *G. lucidum*. There amino acids content was contrast with the antioxidant activity and total phenolic content. Meanwhile the <sup>1</sup>H NMR chemical shifts illustrated signals of a mixture of polysaccharides resonated at  $\delta$  3.0-4.0 ppm, and fatty acids at  $\delta$  0.70-2.30 ppm of the A extract as well as the two signals of anomeric protons  $\alpha$ -glucan and  $\beta$ -glucan of the B extract appeared at  $\delta$  5.36 ppm and 4.47 ppm, respectively. The bioassay *in vitro* immunostimulant activity of all mushroom extracts showed good immunostimulant booster at concentration of 0.5 mg/mL. It was found that the A and B extracts of *G. lucidum* were the most potent immunostimulant activity followed by the A extract of *P. sajor-caju*, and they had higher activity than  $\beta$ -glucan standard with % phagocytic activity of 187.12±2.17, 166.23±0.56, 155.00±2.93, respectively. Future works will focus on their *in vivo* immunostimulant activity, healthy drinks and nutraceutical product development.

# 1. INTRODUCTION

Immune response is an important physiological process to identify and destroy foreign harmful substances as well as organisms to protect diseases, in which macrophages play key roles in phagocytosis, cytotoxicity and intracellular killing activities. Macrophages can resist to pathogens either directly through phagocytosis or indirectly by producing related factor such as nitric oxide (NO), interleukins (IL), tumor necrosis factor- $\alpha$  (TNF- $\alpha$ ) and reactive oxygen species (ROS). [1] In clinical practice, immunomodulators are classified into three categories including immunosuppressants, immunostimulants and immuno adjuvants. Immune system modulations are used common as prophylactic medicine for increasing healthy people where modulations are used common as prophylactic medicine for increasing a number of healthy people whereas immunomodulators are synthetic or semicomponents therefore. synthetic natural have been in growing immnunomodulators interest for overall health-benefiting effects to humans with no or less toxicity [2,3]. Mushrooms,a fungi kingdom member with wellknown medicinal properties has drawn significant interest due to their immunomodulatory and antioxidant attributes, anti-inflammatory, antimicrobial, antidiabetic, cardiovascular protective, hepatoprotective and anticancer potentials [4]. Several active components for example, essential amino acids, proteins, vitamins and mineral, fiber, and polysacchrides in mushrooms immunomodulatory fruiting [5,6]. Mushroom polysaccharides responses display antimicrobial properties against pathogenic bacteria and and viruses inducated the presence of rhamnose, xylose, fuctose, arabinose, fructose, glucose, mannose, manitol. sucrose, maltose and trehalose

prodominantly mushroom-based polysaccharides fractions There was reported [7]. for encapsulated polysaccharides extract in alginate ael beads for external influences protect and extend for their applications [8]. The polysaccharides seem to orchestrate antitumor properties via the activation of host immune response, inferred that the tumor cells have been no destroy directly but instead they were indirectly an impact by stress preventing on the body [9, 10]. Moreover, polysaccharides were compared in different mushroom species such as A. bisporus, A. brasiliensis, Phellinus linteus and G. lucidum and other active compounds, found a positive correlation between glucan level and antioxidation activity in G. lucidum [11]. The methanolic extracts of the wild G. lucidum, native to the Himalaya, including P. ostreatus, P. erynii, P.nebrodensis were clearly documented for their significant antioxidant potential [12, 13]. G. lucidum polysaccharides were was reported for their wroked well against MCF-7 cell lines [14]. Furthermore, the mechanism of polysaccharides for their antioxidant involving the hydrogen atom transfer (HAT) reactions and mostly occur in their neutral form, while the electron transfer (ET) usually mechanism occurs in acidic polysaccharides [15]. The Pleurotus spp. Possess a vast diversity of polysaccharides in particulat heteropolysaccharides and glucans, special biological activities constituting for antioxidant, anti-inflammatory and immunomodulatory activities [16, 17]. There were predominantly consumed mushrooms in Asian countries and have been popularized worldwide according to their potential on essential amino acids, minerals, protein and biological active polysaccharides [18]. The World has been suffereing from the 2019 COVID-19 pandemic and now there were treatment s with medicine available approved from the U.S. Food and Drug Administration (F.D.A.) and the first pill designed to treat symptomatic COVID-19 approved by the UK medicine regulator which these can be deployed as potential therapeutics against COVID-19 [19]. However, the problem with commercial medications is the increased risk of drug resistance development. Natural as mushrooms reported substances such previously, displayed clearly for their antiviral and anti-inflammatory activities and may hold natural remedies against COVID-19 [20]. Therefore, it is important to discover these active ingredients from mushroom bodies to examine their therapeutic potential for immunostimulant activity for leading mushroom-based drug discovery of natural active ingredients from high potential mushrooms in this study.

# 2. MATERIALS AND METHODS

#### 2.1 Materials

#### 2.1.1 Plant materials

Four mushroom species such as Pleurotus ostreatus (Fr.) Kummer, Pleurotus opuntiae (Dur.&Lev.) Sacc., Pleurotus sajor-caju (Fr.) Sing and Ganoderma lucidum (Curtis) were obtained from Dr. Tanapak Invod, Expert Centre of Innovative Agriculture, Thailand Institute of Scientific and Technological Research, Ministry of Ministry of Higher Education, Science, Research and Innovation, Thailand. All the isolates were collected from the mushroom farm in Ratchaburi Province, Thailand. The mushroom pure cultures were transferred into PDA slants and maintained at room temperature. three mushrooms species, The Pleurotus opuntiae (Dur.&Lev.) Sacc., Pleurotus sajorcaju (Fr.) Sing and Ganoderma lucidum (Curtis) were purchased from the local mushroom Tambon Srapattana Community farm. Enterprise in Nakhon Prathom province. Thailand.

#### 2.1.2 Mushroom production

The upper end of the sample bags were opened. Colonized (by mycelium) substrates were arranged on shelves in a greenhouse (temperature, 25-30°C; relative humidity, (85%). The cultures were constantly wet in order to maintain the required relative humidity (85%). The cultures were irrigated by spraying with water, once or twice a day. Primordia will be initiated after 7 days and mature mushrooms (noted as the point where the pileus started to fold) from each bag were harvested at 10 days after open the bags.

#### 2.1.3 Plant preparation

The mushrooms were individually collected, weighed, washed and torn to pieces by hands, then put each of them separately on aluminium foil sheet to dry in the hot air oven, temp  $50^{\circ}$ C for 24 hrs. The dried mushrooms were ground in to powder weighed and kept in zip lock bag at room temperature.

#### 2.1.4 Plant extraction

#### 2.1.4.1 Extraction A

The dried powder of *Pleurotus ostreatus* (Fr.) Kummer, *Pleurotus opuntiae* (Dur.&Lev.) Sacc., *Pleurotus sajor-caju* (Fr.) Sing and *Ganoderma lucidum* (Curtis) were invidually extracted with Delonized water, temp 25<sup>o</sup>C, stirred for 7 hrs. The supernatant was collected after filtered and then freeze-dried under FreeZone 6, 12 and 18 Liter, Freeze dryer gave DI water extracts.

#### 2.1.4.2 Extraction B

The dried powder of *Pleurotus Sajor-caju* (Fr.) Sing, *Pleurotus ostreatus* (Fr.) Kummer, *Pleurotus ostreatus* (Jacq. exFr.) Kummer and *Ganoderma lucidum* (Curtis) were individually extracted with with 80% (80:20 ethanol:water) at room temp. for 7 days, then filtered and dried under vacuum using evaporator gave ethanol extracts. mM. Measured their absorbance by using UV-VIS spectrophotometer at 517 nm.

# 2.2 Total Phenolic Content Analysis

Using Folin-ciocaltea colorimetry method; The stock standard solution of gallic acid solution was prepared conc. 5000 mg/mL in ethanol. The standard solution was pipetted to prepared six concentrations (50, 100, 150, 200, 250 and 300 mg/mL). The sodium carbonate ( $Na_2CO_3$ ) was added, mixed and adjusted to 10 mL of DI water. The solutions were kept in dark for two hrs. and measured their absorbance by using UV-VIS spectrophotometer at 765 nm.

# 2.3 Anti-oxidation Activity Test

Free radical scavenging activity assay; The stock standard solution of 2,2-Diphenyl-1-picrylhydrazyl (DPPH) solutin was prepared conc. 607  $\mu$ M in methanol. Prepared the DPPH

working by pipette DPPH stock solution 1 mL and added methanol 2.1 mL. Pipetted DPPH working solution 200  $\mu$ L into Well Plate and measured absorbance by Microplate Reader Sunrise. The stock standard solution of trolox was prepared into 10 mM. Measured their absorbance by using UV-VIS spectrophotometer at 517 nm.

# 2.4 HPLC Analysis Sample Preparation

**HPLC:** model LC-20A Series, Shimadzu, Japan, column; Shim-pack ISC-07/S 1504 Na.

**Mobile phases:** A:0.2N sodium citrate, pH 3.2; B:0.6N sodium citrate+0.2N boric acid, pH10; C:0.2N sodium hydroxide.

**Flow rate**:0.3 mL/min. **Injection volume**: 10µL. **Post column**: Reaction solution A and B with flow rate 0.3 mL/min.

**Detector**: Fluorescence detector, RF-515, Ex 348nm, Em 450nm. **Calibration curve and linearity**: Measure of amino acids standard for 5 concentrations by using HPLC-LC-20A, duplicate and read, relative percent different ( $(RPD) \le 10$ . Peaks concentration (X) and peaks area (Y), read by Regression Coefficient ( $R^2 \ge 0.99$ .

#### 2.4.1 Sample preparation

Weighed mushroom powder into vaccum reaction tube, added 6H HCl 4 mL then mixed by vortex mixer following by Aspirator. The sample solution was digested at 110<sup>o</sup>C for 24 hrs., adjusted the volume to 10 mL with 0.1 N HCl after the liquid was at room temperature.

# 2.4.2 Nuclear magnetic resonance (NMR) spectra

The <sup>1</sup>H NMR spectra were measured with a Bruker ASCEND 400 FT-NMR spectrometer, operating at 400 MHz (<sup>1</sup>H). The chemical shifts ( $\delta_{H}$  and  $\delta_{C}$ ) were recorded in ppm. with reference to residual solvent signal CDCl<sub>3</sub> ( $\delta_{H}$  7.24), CD<sub>3</sub>OD ( $\delta_{H}$  4.78, 3.31) where appropriated and coupling constants (J) were given in Hz.

# 2.5 Immunostimulant Activity

# 2.5.1 Cytotoxicity: For MTT assay

All cells on 96-well plate were washed out. MTT (10  $\mu$ l, 5 mg/ml) and the medium (190  $\mu$ l) were

added well. in each The cells were then incubated at  $37^{\circ}$ C 5% CO<sub>2</sub> for additional 2 hours. The medium containing MTT discarded, and MTT formazan that was had been produced was extracted with 100 µl of DMSO. The absorbance was read at 570 nm.

#### 2.5.2 Nitrous Oxide (NO) production

For Griess assay, 100  $\mu$ l of Griess reagent was mixed with 100  $\mu$ l of collected medium in a 96well plate. The mixture was incubated for 15 min. at room temperature. The absorbance was determined at 540 nm. with the spectrophotometry. The concentration of nitrite was calculated using a calibration standard curve constructed using sodium nitrite dissolved in DMEM.

#### 2.5.3 Phagocytic activity

The RAW264.7 cells were seeded  $(1 \times 10^5)$ cells/ml) in a 96-well plate with DMEM medium (10% FBS) and incubated at 37°C in 5% CO<sub>2</sub> for 24 h. The cells were cultured with the eight mushroom extracts KC-MU1 TISTR, KC-MU2 TISTR, KC-MU3 Nakhon Prathom, KC-MU4 TISTR, KC-MU5 Nakhon Prathom, KC-MU6 Nakhon Prathom at 37°C. DMEM and betaglucan (50 and 100 µg/ml) were used as negative and positive controls, respectively. The stimulated cells were washed twice with phosphate-buffered saline (PBS), and 100 µl of 0.075% neutral red solution was added to each well, followed by incubation for 3 h at 37°C. Following removal of the unphagocytized neutral red by PBS, destain buffer (ethanol:DW:acetic acid, 50:1:49) was added to each well at shaker for 1 h. The optical density (OD) value of each well was measured at 540 nm using a microplate reader. Cell phagocytosis (%) was calculated as follows:  $OD_S / OD_C \times 100$ , where OD<sub>S</sub> and OD<sub>C</sub> represent the OD values of the stimulated and control wells, respectively. The percentage of phagocytosis in the untreated cells was designated as 100%. All experiments were performed in triplicate.

# 2.6 Statistical Analysis

Significant differences between two normally distributed data were determined with Student's t-test. The values are reported as the means  $\pm$  SEM. Statistical analysis was performed using SPSS (Version 17.0).

# 3. RESULTS AND DISCUSSION

The result of amino acids determination of all mushroom extracts showed the most abundant of amino acids, including glutamic acid, aspartic acid following by leucine and alanine while phenyl alanine and threonine were found varied in Nang-Rom Hungari (KC-MU2), Nang-Fah-Phuthan-Dam (KC-MU4) and Ling-Zhi (KC-MU6) as can be seen in Table 1. Atri, N.S., et al evaluated on five wild edible fungal species of genus Pleurotus using Ultra Performance Liquid Chromatography (UPLC) found amino acids namely aspartic acid, arginine, alanine, proline and tyrosine were detected from the samples, aspartic acid (0.37-0.48%), arginine (0.19-0.23%), alanine (0.19-0.11%), Proline (0.02-0.09%) and tyrosine (0.14-0.20%) were found maximum in Pleurotus pulmonarius, P. sajor-caju (0.44%), P.cystidiosus, P. floridanus and P. sapidus [21] P. sajor-caju possesses different amount of dominant amino acids and found that aspartic acid as well as alanine were similar compared to the amino acids in this study.

The immunostimulant activities result of the eight mushroom extracts included A and B extracts were performed to evaluate cell viability and nitric oxide (NO) production and % Phagocytic activity, respectively using MTT and Griess assays. The results showed that the cell viability found that Ling-Zhi (KC-MU6) was the highest % viability at concentration 0.5 mg/mL following by Nang-Fah-Phutan-Dam (KC-MU4), Nang-Rom-Tao (KC-MU1) and Nang-Rom-Hungari (KC-MU2) in extract B. respectively. The cells viability in A extracts were similarly among the four extracts. Whereas nitric oxide production were varied in the range of 31.06±0.40 to 41.32±1.40 µM, at concentration 0.5 mg/mL in A and B extracts. Meanwhile the % Phagocytic activity of RAW 264.7 cells at concentration 0.5 mg/mL showed that Ling-Zhi (KC-MU6) was the most active. The phagocytic activity of the A extractions A were rinsing from KC-MU3, KC-MU2, KC-MU1, KC-MU5, KC-MU4 and KC-MU6 while the B extractions were KC-MU1, KC-MU2, KC-MU4, KC-MU3, KC-MU5 and KC-MU6, respectively. The previous pharmacological activities report of P. sajor-caju including antidiabetic, antibacterial, antiproliferation, antioxidant and immunological activities. Carbonero, et al [22] documented the in vitro immunological activity using Murine macrophage cell line Raw 264.7, NO and cytokine levels as well as NO, TNF-a levels determination, the results showed ß-glucan induced the production of NO and cytokines TNF- $\alpha$  and IL-1 $\beta$  dose of 0.1-300 µg/ml. While the *P. sajor-caju* both A and B extracts in this study illustrated the activity with the dose between 119-165 mg/ml and  $\beta$ -glucan prominant in B extract was the active compounds.

The antioxidation activity of the mushroom in A extracts were increased from KC-MU4, KC-MU1, KC-MU5, KC-MU3, KC-MU2 and KC-MU6, respectively. The activity in B extracts were risen from KC-MU4, KC-MU2, KC-MU5, KC-MU1, KC-MU3 and KC-MU6, respectively. The highest activity among all extracts was KC-MU6 (Ling-Zhi) with the extraction A which was related its total phenolic content found the highest amount in both Ling-Zhi Extractions. The lowest antioxidation activity and total phenolic content were KC-MU4.

The antioxidant activity using in vitro DPPH, hydroxyl radical and superoxide anion radical scavenging activities of aqueous extracts showed concentration dependent antioxidant activity in all the assays [22]. The aqueous extract with cold and hot water of in vitro DPPH, β-carotene linolenic acid, reducing power ability, phosphomolybdate assay, result of the cold water extract showed higher activity in all assays than hot the water extraction with doses of 50, 100, 250 and 500 µl [23]. Whereas the result of antioxidant activity in this research were in the range of 6.960.31 to 82.55±3.35 mg/ml in the doses of 50, 100, 250 and 300 mg/ml. The previous report of total phenolic content and antioxidant activity on DPPH assays of Ρ ostreatus, P. sajor-caju, P. eryngii and P. cystidiosus exhibited the phenolic content, 17.63±1.30 -7.17±2.24 mg GAE/g and the DPPH assay showed EC<sub>50</sub> values 5.00±0.06-9.13±0.17 mg/ml [24]. The results on the antioxidant and total phenolic content reported were higher than those in this experiment according to the methanol solvent can extract high amount of phenolic compounds, led to higher potent of antioxidant activity than water extract. The <sup>1</sup>H NMR spectrum illustrated the A extracts constituting of a mixture of polysaccharides, resonated chemical shift at  $\boldsymbol{\delta}$  3.0-4.0 ppm and fatty acids at  $\delta$  0.70-2.30 ppm. While the B extracts showed the signals of  $\alpha$ -glucan and  $\beta$ glucan anomeric protons appeared at  $\delta$  5.36 ppm and 4.47 ppm, respectively. The results found the extract. containing of polysaccharides possesses considering a better immunostimulant activity than  $\boldsymbol{\alpha}$ -glucan and  $\boldsymbol{\beta}$ -glucan composition.

# 4. CONCLUSIONS

Our results demonstrated that the glutamic acid, aspartic acid and alanine exhibited the most plentiful in the four mushrooms. The content of amino acids was found less effect to the immunostimulant activity for example. the smallest amount of amino acids found in KC-MU6 which exhibited the highest activity compared to the others. On the other hand, the polysaccharides and  $\alpha$ -glucan as well as  $\beta$ glucan composition as a major component in the four mushroom play a key role on the potential to improve and stimulate the phagocytic ability of macrophage RAW 264.7 to produce NO, especially in Ling-Zhi mushroom. The four mushroom with rich polysaccharides than aglucan as well as  $\beta$ -glucan in the extracts, considering for the greater activity, can be prepared and applied to the development and utilization of future new functional foods and healthy drinks.
